Spectrum Management Chairman : Sh. P.K.Garg, Former Wireless advisor,

RF spectrum is a limited natural resource. It is a collection of a range of electromagnetic radiations of different wavelengths. In India, RF between 9kHz and 3000 GHz are being used for 40 different types of services like fixed communication, mobile communication, broadcasting, radio navigation, radio-

location, fixed and mobile satellite service, aeronautical satellite service, radio navigational satellite service etc. Some of the characteristics of the radio frequency spectrum are that it has no boundaries and cover a large terrestrial area. It is susceptible to interference and it must be used efficiently, optimally and economically in conformity with the provisions of national and international laws.

The best allocation aspects for Indian scenario and the existing tools to frame policy on spectrum refarming and flexible optimum usage by future radio technologies will be examined by a team of experts from industry and academia.

Green ICT Chairman : Dr. Anand Prasad, Senior Expert, NEC Corporation

The Green ICT activity of GISFI is working on energy efficiency aspects by making things green with ICT and also making ICT green. The concept of making things green with ICT is none other than reducing Green House Gas (GHG) emission. The sectors which mainly contribute to GHG are energy,

electronic industry, construction, waste disposal, agriculture and ICT. In the Green ICT activity of GISFI the members are working on developing standards that fulfill Indian requirements while having a global impact. Currently initial draft version of two of the Green ICT deliverables are available; these transport, power generation, deliverables are on making

ICT green and using ICT to make other sectors green. COAI, VNL, TCS, IIIT, Ericsson, NEC Corporation and several other members, including individual members, are actively working in this group. The Govt. Of India is also conscious of the urgent need to reduce carbon foot prints.

Service Oriented Network (SeON) Chairman : Dr. Parag Pruthi, CEO, NIKSUN Inc. USA



Cross Digital divide to bring Services to rural India

The present day IN (Intelligent Networks) connected to PSTN and 2G/3G PLMN networks are Circuit Switched networks which will become a thing of the past if the services to subscribers are put through a Service Layer connected to IMS (IP Multimedia Subsystem) and other PS (Packet Switched) networks. The deployment through Service layer will be faster due to the

standardisation of network with the availability of more vendors IP-oriented architecin the ture. The migration from the circuit switched networks to packet switched networks may take a longer time frame. The convergence in service layer independent of CS or PS network will make devices free from the access or switching technology. The user can have the same feel irrespective of the device being used Mobile, fixed, and IP phones.

GISFI is evolving a strategy in standardisation of Service Oriented Network (SeON) architecture for the convergence in service layer.

SeON means the same service layer infrastructure is connected to both the CS networks

based on SS7 signaling and PS networks based on IMS and all enabled devices connecting from either network to be part of the same services. This convergence helps in personalization, provisioning, and billing. It will have the benefits of Fixed-Mobile Convergence (FMC), Multimedia services integration, multiple device support, billing independent of services (voice, data, land line, mobile integrated payment), increased business groups access and social interactions.

Internet of Things (IoT)

Internet of Things (IoT) can mean several things including Machine to Machine (M2M) communications. M2M refers to technologies that allow wireless and wired systems to communicate with other devices of the same ability. The IoT M2M wireless communications is an emerging technology that enables communication between machines, (devices,) where different devices establish communication and exchange information. We observe that several stan-

dardization activities are taking place worldwide in the field of M2M. GISFI's focus is on M2M relevant to Indian context on M2M over mobile networks. The applications considered (in order of priority for Indian scenario) are e-Agriculture, e-Education, e-Health, Connected Home, Smart Grid and other Utilities, Intelligent Transportation System, Security / Safety / Surveillance, Banking and Industrial Machines. M2M Connected Devices General Net-

work requirements are Authentication, Provisioning, Session management, Device interoperability testing & verification, Revenue assurance, Charging & billing, Coverage & capacity, Roaming & mobility, Customer care.

The Technical working Group comprising of TCS, NEC, Ericsson, NIKSUN, SIT, I4CT, IIIT-A and LNMIIT are developing standards in the M2M area of IoT.



Internet of Things to make a smarter world



Future Radio Access Technology Chairman : Sh. Rajiv Mehrotra, Chairman, VNL,INDIA

Research on future radio access systems, supporting up to 100 Mb/s with wide-area coverage and up to 1 Gb/s with local-area coverage is currently undertaken around the world. Spectrum flexibility is identified as one main requirement for future radio access systems to make it feasible for deployment in a wide range of spectrum allocations with Multihop relaying to help extend the data range for higher rates and multiple-antenna configurations. A

packet-centric data flow processing, optimization towards the transport of packets are some of the few research orientations in the technology used.

The packets are segmented in the existing cellular systems. But new protocols may be decided for the future radio access systems for scheduling mechanism and the retransmission to operate on complete packets instead of segments to support wide-area coverage of data rates in the order of 100 Mb/s in a cost-efficient manner.

A Team guided by Sh.Rajiv Mehrotra, Chairman, VNL, India is working in this area of standardisation.

Perspectives of Indian ICT sector

The information and communication technology (ICT) sector has emerged as the prime mover of Indian economy and it has catapulted the Nation on the world stage. It can be classified in three categories namely IT services and software; IT enabled services like (BPO) and Hardware segments comprising of IT, Electronics and Communication equipments. Although the growth is predominantly in IT services, the communication sector also grown by expansion of Mobile phones in the nook and corner of the country. The telecom service sector with an investment of Rs. 200,660 crore (\$45.5 billion) in 2005-06 earned a revenue of Rs. 86,720 crore (\$19.7 billion) which is a rise of 21% than previous years.

The Telecommunication is the lifeline of the rapidly growing Information Technology industry and the Internet subscriber base which is more than 7.5 million. The key growth drivers in the Indian Telecommunications market are Foreign Direct Investment, Mobile Tariffs, Government Initiatives, Handset Manufacturing, Valueadded Services. The area of opportunity lying ahead are Value-added Services, IPTV Market, Network Infrastructure, 3G Infrastructure, WiMAX, Semiconductor Industry, Mobile Handset Market and Mobile Number Portability. The key players in Indian Telecom are Bharti Airtel Ltd., BSNL, Vodafone Essar Ltd., MTNL, Reliance Communications Ltd., Tata Teleservices Ltd. ,Idea Cellular Ltd., and Aircel. The Indian ICT sector is poised for development and opens up new opportunities.
